


Participant Biographies

COUNTRY DELEGATES

Brazil

GARO BATMANIAN has previously worked in the World Bank offices in the USA, Brazil and China. His last position was Global Lead for Forests, Landscape Biodiversity, responsible for coordinating the implementation of an integrated green agenda. Garo also coordinated the World Bank's Forest Action Plan, managed the Forest Investment Program (FIP) for the World Bank, and the Program for Forests (PROFOR), the Global Partnership for Sustainable and Resilient Landscapes (PROGREEN)



and the Pilot Program to Conserve the Brazilia Rainforest. Earlier in his career, he was the LAC Program Director of WWF-USA, and the first CEO of the WWF Brazil having led the development of the Amazon Rainforest Protected Areas Initiative (ARPA). Garo is also the founder of FSC-Brazil, served as its first chairman and led the process of developing national standards for natural forest management in the Amazon and for plantations. Garo holds a Ph.D. in Ecology from the University of Georgia, USA.



MARCUS VINICIUS ALVES holds a bachelor's degree in Forestry Engineering, from the University of Brasilia, Brazil, and a Ph.D. in Forest Sciences, from the University of Wisconsin-Madison, USA. During 24 years, Marcus Alves worked as a research scientist at the Forest Products Laboratory of the Brazilian Forest Service, where he served as its Head for 11 years. In 2010 he was appointed to the Board of Directors of the Brazilian Forest Service, where he became responsible for forestry development, concessions and monitoring, until 2019. Since January, 2023, Marcus Alves has been

the Director responsible for the Rural Environmental Regularization National Program and Deputy Director-General of the Brazilian Forest Service.

Canada

VINCENT ROY is a forest engineer and holds a Ph.D. in forest science from Laval University (Québec, Canada). He started his career as a research scientist in plantation silviculture for the provincial government of Québec. In 2009, he was nominated Research Director at the Canadian Forest Service (CFS). His national responsibilities have included being national project coordinator of the forest productivity, forest integrity and climate change research programs. He is currently acting Director General for the Canadian Wood Fibre Centre, a research branch within the CFS, and he leads the



science program "Developing Sustainable Fibre Solutions". Throughout his career, he has published 24 papers in peer-reviewed journals.

RESOURCE ADVISORS

TASSO AZEVEDO is a forester and social entrepreneur on forests, climate and sustainability. He was a co-founder of MegaFlorestais and played a major role in the last meeting held in Brazil in 2008. Tasso is the general coordinator of MapBiomas (land cover and land use change monitoring initiative) and Chair of



the Board Connection Forest People initiative. Tasso was founder and general director of IMAFLORA and General Director of the Brazilian Forest Service. He is a visiting scholar of Brazil Lab at Princeton University, an Ashoka Senior Fellow (2021) and Skoll Award Fellow (2022) and board member of Rainforest Alliance, Preferred by Nature and Santander.



DAVID BRAND is the founding Chair of the International Sustainable Forestry Coalition—a group of private forestry companies dedicated to supporting the transition to a nature positive bioeconomy. He has over 40 years' experience in forestry investment, forest management, science, and public policy, and is dedicated to innovative, responsible investment strategies in the forest sector and associated assets. From 1985-1995, David worked with the Canadian Forest Service as a scientist, director of scientific programs, and ultimately as national Director-General of Science and Sustainable

Development. David has a PhD from the University of British Columbia and a Bachelor of Science in Forestry from the University of Toronto in Canada.

SALLY COLLINS has a 40 year history managing forests, from the local level (Forest Supervisor of Deschutes National Forest for 8 years) to the Associate Chief in Washington DC for 8 years. She also served as the first Director of the Office of Environmental Markets in US Dept of Agriculture (2008-10), set up to pursue new and innovative markets for forestry and agriculture, such as water and carbon markets. He is an agronomist, graduated from São Paulo State University (UNESP), and has a master's degree in Territorial Planning from Santiago de Compostela University in Spain. Marcio has implemented several sustainable development projects, working closely with traditional communities and indigenous peoples in the Atlantic Rainforest and Amazon region. Since 1997, he has actively managed projects on agroforestry, organic agriculture, sustainable forest value chains, community

based ecotourism and forest management and certification. Marcio has provided auditing services for Smartwood / FSC / IMAFLORA and the Union for Ethical Biotrade (UEBT) in Latin America. W the Health and Happiness Project (PSA) in the Tapajos and Arapiuns rivers region, in Santarém, Pará, Brazilian Amazon, he launched the "knowledge journeys", boat trips with pedagogical, scientific and/or technical purposes, and has already promoted more than 30 expeditions since 2009. Marcio currently leads indigenous economic and governance projects in Latin America, acting as the director of the Territorial Governance Facility for Forest Trends' Communities and Territorial Governance Initiative, and also represents the NGO Seacology in Brazil, supporting local communities living in islands to access funds to strengthen the capacities for local development, environmental conservation and cultural strengthening.

ANDREW MICCOLIS is CIFOR-ICRAF's country coordinator for Brazil, where he leads initiatives aimed at agroforestry-based forest and landscape restoration, appraisal, design, and expansion of scale of agroforestry options coupled with other sustainable land-use practices. An accomplished leader with a background in agriculture and molecular genetics, she serves on several boards and has been recognized for outstanding contributions to innovation, gender equity and sustainable prosperity creation. Born in Rwanda and raised on three continents, Dr Ubalijoro

knew from a young age that she wanted a career in service to the world. She earned a bachelor's degree in general agriculture and a master's and a doctorate in molecular genetics from McGill University, where she studied improving productivity in agriculture. LESLIE WELDON is an experienced leader in natural resource conservation and organizational development. Over the past 41 years, Leslie served in a diversity of senior executive and field-based positions within the USDA Forest Service including Deputy Chief for Work and Environment and performance, National Forest System, Regional Forester, and External Affairs Officer. She has led US Forest Service conservation work in Washington State, Oregon, Montana, and Washington, DC. She has shaped conservation policy, guided aquatic and forest restoration programs in a diversity of

ecosystems and communities, and led employee performance and diversity, equity, and inclusion programs for the Forest Service and USDA. She chose her vocation while a teenager and after participation in the Youth Conservation Corps in the late-70's. She serves on the boards of Trout Unlimited, Arbor Day Foundation, Yellowstone to Yukon Initiative, The Corps Network, and the University of Washington Center for Environmental Forensic Science.

He is active in the Articulation of Indigenous Peoples of Brazil (APIB) and former Vice-Coordiantor of the Coordination of Indigenous Organizations of the Brazilian Amazon (COIAB). He has also served as the president of Federação dos Povos e Organizações Indígenas de Mato Grosso (FEPOIMT), an initiative founded in 2018



to respect sociocultural diversity and promote the leading role of the 43 Indigenous Peoples of the State of Mato Grosso. He is an alternate Board member of Podaali, the first Indigenous-led fund of the Amazon region, an initiative of COIAB.



HILTON LUCAS GONÇALVES DURÃO is a quilombola, Afro-descendent territory, from the community of Porto Alegre, in the municipality of Cametá, Pará, Brazil. He is an agronomist with a Master's degree in Family Farming and Sustainable Development, and is currently studying for a PhD in Biodiversity and Biotechnology at the Federal University of Pará (UFPA), with a focus on the Amazon. He has extensive experience in agricultural technical assistance, working with traditional communities in the northeast

of Pará, especially in the cocoa and açaí production chains and forest management. His research includes studies on environmental preservation in quilombola territories in the Legal Amazon, with an emphasis on measuring native vegetation. He also carries out research into botany, ethnobotany and agrobiodiversity.
